### **Frequently Asked Questions**

#### **Application**

**1) Who can participate?**

The Competition is open to undergraduates and graduate students in Singapore enrolled in universities.

**2) Who can be in my team?**

You can form a team with students from the same university or different universities. The teams should consist of three to four students.

**3) Can I join more than one team?**

No, please join one team only.

**4) Is there an entry fee for this Competition?**

No, participation for this Competition is completely free.

**5) How do I register for the Competition?**

To register, complete the registration form available on the Competition's [website](#) by 28 February 2025. Please only send one document per team.

**6) When is the deadline for registration to the Competition?**

The deadline for registration is 28 February 2025.

**7) When is the deadline for the submission of my solution?**

The deadline for submission is 1 April 2025.

**8) Does this challenge require my physical presence?**

Shortlisted teams will be invited to present their proposal in-person at the final presentation.

## Competition Guidelines

### 9) How does this Competition work?

You will need to select a real-world company for your case-study. As part of the Internal Audit team, you will be tasked with assessing the company's governance, risk management and internal controls to identify issues, and provide recommendations to potentially correct and mitigate those issues through practical and impactful solutions.

### 10) What is the expected format of the proposal?

All teams will be required to submit their proposal deck (PDF) and video presentation online to the email at [events@iia.org.sg](mailto:events@iia.org.sg). The deck should consist of no more than 10 slides, and the presentation recording should be limited to 10 minutes.

### 11) Do the cover slide, executive summary, and thank you slide count towards the 10-slide limit?

The cover slide and thank you slide will not be counted as part of the 10-slide limit. However, the executive summary will be included in the slide count.

### 12) Will case study materials be provided, or are participants expected to select real-life cases available online?

Case study materials are not provided, but there is flexibility to select or develop a case study. Please refer to the [Case Study Guidance](#).

## Selection Of The Finalists

### 13) What happen if my team is selected as a semi-finalist?

Shortlisted teams will be invited to the semi-finals, where they will deliver a 30-minute Zoom presentation followed by a Q&A session.

### 14) When and where the finals will take place?

Successful teams will advance to the finals, where they will deliver a 30 minute in-person presentation, judged by distinguished industry experts, followed by a Q&A session. The finals will take place on 28 May 2025.

### 15) What is the prize for the winners?

The total cash prize of \$6,000 will be distributed as \$3,000 for 1st place, \$2,000 for 2nd place, and \$1,000 for 3rd place.
