Sustainability is increasingly gathering momentum globally. This has gained much traction in Singapore when the Monetary Authority of Singapore (MAS) introduced guidelines on Environmental Risk Management in December 2020 for adoption by June 2022 to promote sustainable finance. Financial institutions (FIs) are now expected to play a crucial role in the transition towards an environmentally sustainable economy by channelling capital through green financing and investment activities. In April 2022, the International Sustainability Standards Board (ISSB) released its first exposure draft on the global standards for sustainability disclosure, setting out the requirements for public companies to provide complete, comparable and verifiable information on their exposures to climate-related risks and opportunities.

In this panel discussion, Chief Sustainability Officers and thought leaders from the FIs will deliberate on the opportunities and challenges that Financial Institutions encounter in implementing the guidelines and disclosure standards and the roles of internal audit (IA) working with stakeholders and management to manage environmental risks and provide assurance on sustainability disclosures.
